YOU ARE REQUESTED TO REPORT ON <u>13.06.2022 (Monday)</u> by 09:00 AM FOR COMPLETION OF PRE-RECRUITMENT FORMALITIES AT THE ABOVE VENUE. YOU WILL BE INFORMED REGARDING THE HOTEL ARRANGEMENTS FOR YOUR STAY ON REPORTING/COMPLETION OF THE PRE-RECRUITMENT FORMALITIES. PLEASE NOTE THAT BANK WILL PROVIDE ACCOMMODATION FACILITY ONLY TO THE CANDIDATE.

Further, during the documents verification process on **13.06.2022** at the above mentioned venue, we have also arranged for **online bio-metric verification** wherein the biometric credentials shall be verified with those obtained by IBPS during the recruitment process. The candidates will be permitted to join the Bank only after verification of documents and also confirming the identity through bio-metric verification.

**On completion of the Induction training,** you will be posted to a Branch/Office **anywhere in India**, which will be informed to you during the course of training.

## PLEASE BRING THE FOLLOWING CERTIFICATES (ORIGINALS ONLY).

- i. Medical Certificate of physical fitness in Form F.1461 from a Govt. Medical Officer not below the rank of an Assistant Civil Surgeon along with the Self Declaration Form F.1462, duly witnessed by the medical officer (A CANDIDATE SHOULD BE MEDICALLY FIT TO DISCHARGE HIS/HER NORMAL DUTIES. HENCE PLEASE NOTE, THAT ONLY CANDIDATES WHO ARE MEDICALLY FIT MAY REPORT ON THE ABOVE MENTIONED DATE, INCASE HE/SHE IS TEMPORARILY UNFIT HE/SHE MAY SEEK FOR EXTENSION OF JOINING TIME).
- ii. Character & Conduct Certificates from three respectable persons **not related to you** of which, one must be from the Principal / Head of the Department of the College / University last attended and the remaining two from Gazetted Officers or Bank Officers.
- iii. Employment Exchange Registration Card (**if registered**). In case the candidate has not registered with the Employment Exchange / the card has already expired this clause is not applicable for now.
- iv. An <u>unconditional relieving letter</u> and good conduct certificate (issued by the competent authority) from your previous employer/s and also from the present employer, wherever applicable (PLEASE NOTE, UNCONDITIONAL RELIEVING LETTER (IF APPLICABLE), SHOULD BE DULY SIGNED BY THE AUTHORISED SIGNATORY OF THE HR DEPARTMENT OF YOUR CURRENT/ PREVIOUS EMPLOYER.)

- vi. "Attestation Form" in Three sets (Originals) duly mentioning the <u>full postal address of the</u> <u>Office of the Superintendent of Police</u> under whose jurisdiction your residence comes to enable us to call for the required report from the Police Authorities.
- vii. <u>As per the policy of terms and conditions you are required to execute a Bond</u> of Rs. 100,000/- (Rupee One Lakh only) along with applicable GST and charges at the time of verification of documents (Bond format will be provided at the time of joining)

### <u>Please bring copies of the following certificates duly attested by a Gazetted Officer</u> along with the "original certificates" without fail for verification:

- i. SSLC Certificate certifying the Date of Birth;
- ii. Mark Sheets of Qualifying Exam(s) (from SSLC onwards);
- iii. Degree Certificate or Provisional Certificate;
- iv. Caste Certificate issued by the Competent Authority <u>in the proforma prescribed by the</u> <u>Government of India</u> with the correct name of the Sub Caste (in case of belonging to Scheduled Caste / Scheduled Tribe / Other Backward Classes category), if applicable.
- v. In case of OBC candidates Caste Certificate should not be older than one year as on date of joining, and should contain the creamy layer clause.
- vi. In case of candidates selected under EWS category, candidates should submit valid "Income & Asset Certificate to be produced by Economically Weaker Sections" issued by the Competent Authority in proper format.
- vii. Medical Certificate from Competent Authority in case of Persons with Disabilities in the format prescribed by Govt. of India.
- viii. If PRAN Number has already been allotted to you, self-attested copy of the PRAN CARD shall be submitted at the time of joining.

Also, note to bring the following:

- 1. <u>Self attested copy of the Pan Card (mandatory)</u>. In case you are not having a Pan Card the same should be applied and the proof of acknowledgment (containing the Ack. Number) for having applied for the same shall be submitted at the time of joining and intimate the PAN number as soon as it is received by you.
- 2. Aadhaar Card copy.
- 3. 5 additional copies of passport size photographs

Further, please note that in case you do not report on the above said date at the venue mentioned, it will be presumed that you are not interested in joining the Bank and the Bank may take appropriate steps as deemed fit in this regard.

Further, Candidates to strictly note to follow the rules/guidelines as applicable for the respective states/UT issued by the Government from time to time, with respect to quarantine and travel.

allowed entry. In case any of the responses in declaration suggest COVID 19 infection/symptoms, the candidate will not be permitted inside the venue.

All candidates will be checked with Thermo guns at the entry point for temperature. In case, any
person is observed to be having above normal temperature (> 99.14° F) or displaying any symptoms
of the virus, they will not be allowed entry into the venue.
