OFFER OF PROVISIONAL ENGAGEMENT

Memo No. A-1/Limbuguri BO/BPM/Rectt/2023 dated at tinsukia 21-09-2023

In response to the notification No.17-67/2023-GDS

Dated 31.07.2023

It is informed that Shri/Smt./Ms **Midrashi Gogoi** Son / daughter of Late **Hemonta Gogoi** whose date of Birth is 10.12.2001 and belongs to OBC category has been selected for provisional engagement against OBC Category to the post of BPM, Limbuguri BO in account with Rangagora SO under Tinsukia Division with TRCA slab Level 1, Rs. 12000/-

2. Shri/Smt./Ms **Midrashi Gogoi** Son/daughter of Late **Hemonta Gogoi** should clearly understand that his/her selection for provisional engagement as ABPM, Saikhowaghat Sub- Post Office in account with Tinsukia SO shall be liable to be terminated in accordance with Department of Posts, Gramin Dak Sevak (Conduct and Engagement) Rules, 2020 as amended from time to time.
3. Shri/Smt./Ms **Midrashi Gogoi** is hereby informed that he/she will have to produce all the documents in originals, i.e., Educational qualification certificates, caste certificate, Persons with Benchmark Disability certificate, certificate of date of birth etc. for verification within 15 days of receipt of this letter, failing which it will be presumed that he/she is not interested to join the post of BPM Limbuguri BO and his/her name will be deleted from the selection list. Further, he/she will have no claim for engagement as BPM Limbuguri BO
4. At the time of joining, the candidate will have to give undertaking that he/she has adequate independent means of livelihood other than the TRCA (allowances) to be paid by Government.
5. The candidate who is selected as Branch Postmaster will have to provide accommodation for Branch Post Office at Branch Office Village, if accommodation is not provided by Central Govt/State Govt/Gram Panchayat or any other local Body as per the standards prescribed by Directorate order no.17-31/2016-GDS dated 25.06.2018 & 28.09.2018. As per Rule 3-A(vii) of GDS (Conduct and Engagement) Rules 2020, he/she should take up residence in Post Office village within a month of selection but before engagement. Failure to reside in place of duty for GDS BPM after engagement shall be

treated as violation of conditions of engagements and liable for action under GDS (Conduct and Engagement) Rules, 2020 resulting in removal/dismissal from engagement.

5.1 Failure to reside within the delivery jurisdiction of the Post Office for other categories of Gramin Dak Sevaks after engagement shall be treated as violative of conditions of engagement and liable for action under the GDS (Conduct & Engagement) Rules, 2020.

6. The candidate will have to furnish declaration for having knowledge of cycling and in case he/she can ride a two wheeler scooter or motor cycle, that will be considered as knowledge of cycling. The candidate has to submit a declaration to this effect and has to produce driving license.
