LETTER FOR FEES COLLECTION AS PER MSW RULES, 2016

TO

PRINCIPAL TIMESUKIA COLLEGE,

This is to inform you that under the MSW Rules 2016, it is mandatory for every SCHOOL/COLLEGE waste in three bins and hand it over to vehicles only. Waste should not be littered anywhere.

MSW Rules 2016 Clause (4) defines Duties of waste generators - (1) Every waste generator shall,-

(a) Segregate and store the waste generated by them in three separate streams namely bio-degradable, non biodegradable and domestic hazardous wastes in suitable bins and handover segregated wastes to authorized waste pickers or waste collectors as per the direction or notification by the local authorities from time to time."

You are also requested to arrange for appropriate bins within your commercial space/premise and handover the waste in the door to door collection vehicle. The vehicle comes every day except Sundays. You are also instructed to keep suitable size and number of dustbins of Green (organic), Blue (Inorganic) and Red (Hazardous) colour to store segregated organic and inorganic waste.

The monthly fee for college campas is Rs 1000 (One Thousand Rupees Only). The project has been there since 1st of July 2019. Hearby we request you to please make the payment of garbage collection of your premises for last five months (i.e. July '19 to Nov '19) to Care North East Foundation as per management of Solid Waste Rules 2016. The Rate List and TMB circular is attached herewith.

NOTIFICATION

This is for information that as per Municipal Solid Waste (Management and Handling Rules) 2016, segregation of waste at source and collection of waste at segregated manner from households and commercials is mandatory. In view of the above all Commercial Establishments/Public and Private Institutions/Traders/Shops/Vendors/Schools-Colleges etc. functioning under the jurisdiction of Tinsukia Municipal Board area are required to maintain two sets of dustbins i.e., Blue Bin for dry/recyclable (paper, plastic, glass metals etc.) waste and Green Bin for organic/wet waste (fruits, vegetable, leftover food, leaves etc.) and store the waste accordingly and handover only in the vehicle. The service fee for door to door collection from residential houses are Rs. 75/-, Small shops Rs. 100/- and Big shops are Rs. 300/-. Other rates are as per SBM (U) guidelines.

Further, it is to mention that the officials from the Tinsukia Municipal Board will check all Commercial Establishments/Public & Private Institutions/Traders/Shops/Vendors/School-Colleges etc. for compliance of the same from time to time. Tinsukia Municipal Board will penalize for failure to comply with the directions of the notification with a penalty of 500/- to 5000/- Rupees. If any Commercial Establishment fails to comply by more than 2 times for the above offence, the trade license of such establishment will be cancelled by the Tinsukia Municipal Board immediately. All establishment are asked to pay service fee as per the Government of Assam/TMB Resolutions and guidelines.

This notification will come into force from 1st of August 2019.
